

2019 FROZEN SEMEN BREEDING CONTRACT  
VS FLATLINE

I hereby agree to breed the Mare \_\_\_\_\_, Registration # \_\_\_\_\_ to the stallion VS FLATLINE, Registration # 5292835, using frozen semen for the 2019 season. The Stallion Fee is \$ 3,250.00 including a booking fee of \$ 350.00.

1. **EE Ranches, Inc:** EE Ranches, Inc hereby reserves for the Mare Owner one breeding to the stallion VS Flatline during the 2019 breeding season. The reservation will be secured by the Mare Owner's payment of a Booking Fee which is non-refundable and shall be applied to the Stallion Service Fee and included with this contract. If more than one pregnancy is desired from VS Flatline through embryo transfer a Contract and Stallion Service Fee will be required for each breeding. If more than one embryo is produced and multiple embryos are transferred than the Mare Owner must notify EE Ranches within 48 hours of transfer and immediately enter into an additional Contract(s) and pay the required Stallion Service Fee, which is due immediately. All contracts require a \$350.00 non-refundable booking fee, regardless of whether it is through a service auction, donated, or reduced breeding agreement. Payments are to be made payable to EE Ranches, Inc.
2. **Mare Owner:** The Mare Owner represents the Mare as healthy and in sound breeding condition and registered with the designated registration organization.
  - The Mare Owner agrees to attach a copy of the Mares registration papers
  - The Mare must be managed by a veterinarian qualified in equine reproduction. It is recommended that a thorough veterinary reproductive exam and normal uterine cytology and/or uterine culture be performed before breeding commences.
  - The Mare Owner agrees to use the semen released here under solely to breed the designated Mare in accordance with this Breeding Contract together with the rules and regulations of the registration organization.
  - The Mare Owner agrees to have the Mare checked by ultrasound no later than 18 days after insemination. If ultrasound is unavailable, Mare Owner agrees to have Mare checked for pregnancy by a licensed veterinarian within 30 days of insemination. Mare Owner agrees to provide EE Ranches, Inc with the results of the pregnancy exam no later than 30 days after insemination and last breeding date.
3. **Charges:** The Mare Owner and/or any individual executing this Agreement shall agree to pay prior to semen being released the following.
  - (a) Booking Fee (due with the signing of this contract) \$350.00
  - (b) Balance of Stallion Service Fee \$2,400.00
  - (c) Frozen Semen Fee \$500.00

Payment of all charges in full will be required prior to release of semen via cashier's check or credit card.

4. **Release of Semen:** The breeding fee and frozen semen charge allow up two doses of frozen semen to be allocated to a mare in one breeding season with one dose at a time being released. If an additional dose is requested after the first two, a fee of \$250 will be required before semen and will be released. Failure to get a mare pregnant within the season will mean the mare has to be rebreed the following season and will be subject to the rebreed fee and additional frozen semen charge in force for that year.  
Frozen semen will be released 1 dose per cycle (8 straws) with up to 2 doses per breeding. Additional frozen doses require additional fees as stated above. \_\_\_\_\_ Initial here

All shipping fees, container rental, and/or other charges billed by this Storage Facility are the responsibility of the Mare Owner and are due directly to the facility in accordance with their policies.

6. **Live Foal Guarantee:** This contract between the Mare Owner and EE Ranches, Inc for the above-named mare is non-transferable and provides for one return breeding, in succeeding year only, for the Mare (or agreed upon substitute) that fails to produce a live foal (newborn foal that stands and nurses without assistance). This may be satisfied at the sole discretion of EE Ranches, Inc by 1) shipping semen or 2) rebreeding onsite to be performed by EE Ranches, Inc. In the case of a miscarriage, stillborn foal, or death of mare after having been pronounced in foal, Mare Owner will provide EE Ranches, Inc with a written confirmation from a licensed veterinarian stating the cause of death, within 7 days. Rebreed services will require a \$650.00 rebreed fee plus additional frozen semen charges. If the mare owner fails to rebreed the mare the following year, then any and all fees becomes forfeited, the right to rebreed is cancelled and the Stallion Owner is released from all further obligation of this contract, unless otherwise agreed upon in writing and signed by both parties. A Breeder's Certificate shall be issued at the request of the Mare Owner and when all fees have been paid in full.
7. **General:** There shall be no cash refunds under this Contract. This contract is not assignable and is transferable only as stated above and with written consent by both Mare Owner and EE Ranches, Inc. Mares will not be put on the Stallion Breeding Report unless all fees have been paid in full and breeding dates and pregnancy status have been provided to EE Ranches, Inc. Late notification may result in additional fees at Mare Owner's expense to be put on the breeding report. It is the Mare Owners responsibility to contact EE Ranches, Inc with the breeding dates and pregnancy status.
8. **Color Guarantee:** We do not offer a color guarantee on APHA or ApHC mares!
9. **Other Provisions:** When Mare Owner, or authorized representative, signs and returns this contract to EE Ranches, Inc, it will be a binding contract on both parties, subject to the above terms and conditions. This Contract is not transferrable or assignable. The Mare Owner/Lessee agrees that interest of 1.5% will be charged on all accounts that are 30 days past due. The Mare Owner/Lessee agrees to pay all reasonable collection and attorney fees incurred by EE Ranches, Inc in attempting to collect any outstanding balance. This contract is governed by the law of the State of Texas.
